## HOW CAN I TRUST THE ACCOUNTS OF JESUS?

Eyewitness accounts are key.

- The case for Christianity and the truth of Jesus is built on the reliability of eyewitness accounts.

In a court case, juries are asked to evaluate the reliability of a witness based on four major themes:

1. Were they there?
2. Is there corroborating evidence?
3. Are they honest and accurate over time?
4. Do they have a bias—a reason to lie?

## LET'S TEXT THE ACCOUNTS OF JESUS—THE GOSPELS AND THE NEW TESTAMENT.

### 1. Were they there?

- How close to the events they describe were the Gospels written?
- Acts, written by Luke, is missing too many big events for it to have been written late. Jesus: 33 AD | Acts: 60 AD

### 2. Is there corroborating evidence? And...

### 3. Do they remain the same overtime?

- The eyewitnesses and writers of the Gospels had students who wrote books (six main early church fathers). These writings continued to tell the same account of Jesus. Then there are many other writers before Christianity became accepted (so before 313 AD). These were Christians who liked Jesus.
- In the five hundred years after Jesus, there were non-Christians who liked Jesus and wrote about Him for their own means (non-canonical writings). These were Non-Christians who liked Jesus.
- Before 313 AD, there were people who did not like Jesus who wrote about Him. These were Non-Christians who didn't like Jesus.
- You can reconstruct the story of Jesus using each of these types of writings. Jesus cannot be eliminated from history.

#### 4. Do they have a bias?

- The motivation to lie typically falls under three categories: power, finances, and sex.
  - The disciples of Jesus gained none of this by holding to Jesus' life, death, resurrection, and teaching. They held to what they had witnessed at great cost to themselves and often their family.

  6. How would you explain the reliability of the New Testament accounts about Jesus to someone who was interested in who Jesus was?
